Herewith we transfer the approval as "BMW Longlife-04" oil, given for engine oil code of "Lubrizol Ltd" to the Reblend oil "Comma Syner-Z 5W-30", SAE 5W-30 of MOOVE LUBRICANTS LIMITED. Consequently it is approved according to our release procedure for BMW Longlife engine oils (10<sup>th</sup> edition, June 2022) for the usage in BMW engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter and can be further extended for a maximum of two years in each case (approval expires prematurely if the reference formulation loses its approval). Prolongations have to be requested within BFAS (BMW Fluid Approval System), the extension date can be taken from BFAS, reference EOA-RBL-2024-04233.


